### USDA Offers Disaster Assistance to Farmers and Livestock Producers Impacted by Recent Winter Storms

Winter storms create significant challenges and often result in catastrophic loss for agricultural producers, especially for those raising livestock, row crops and vulnerable crops like citrus. Despite every attempt to mitigate risk, many agricultural operations suffered losses. When disaster strikes, USDA is here to help.

As agricultural producers move into recovery mode and assess damages, they should contact their local USDA Service Center to report losses and learn more about program options available to assist in their recovery from crop, land, infrastructure and livestock losses and damages.
